# **Eminent Domain Solutions Center**



#### **Problem:**

- Eminent Domain is complicated and controversial, and many states have unique approaches.
- The information asymmetry between landowners and developers leads to higher project costs and greater tension, slowing needed infrastructure build outs.
- There is a lack of data transparency and analysis on how the process works and its impact on infrastructure.
  - Current analysis is mostly episodic (a professor writing a single article) or scattershot in coverage (practitioner writes law review analyzing particular state).
  - What's missing is the big picture that also informs local interests about how others do it.
- There is no neutral clearinghouse resource for all eminent domain law and policy nationwide.
- No one is facilitating objective data sharing and comparison of approaches.
- There is growing relevance for eminent domain in future infrastructure projects, which includes a
  doubling of grid capacity through wind and solar projects, high-voltage transmission lines, and more, as
  well as new hydrogen and carbon dioxide pipelines in additional to traditional infrastructure.

#### **Solution:**

- More complete data and a fuller analysis of all costs will point to better policy solutions to serve all stakeholders.
- Aii will provide a neutral platform laying out information, not characterizing it or taking a position.
- Aii hosts a platform intended for problem solvers to come together.
  - State legislators, judges, landowners, developers, etc.
- The resource will include a survey of state laws and analysis of each states' approaches to facilitate comparison between states and better understanding of the process in any individual state.
- The platform is constantly updated. This is not a snapshot in time or survey of current law, but an up-to-date database going forward.
- Includes a background page for individual state analysis articles, so people can access more particular analyses from the main big-picture database.

## **Project Phases**

Our comprehensive and continually updated resource on eminent domain law and policy is designed to serve as an invaluable tool for a diverse set of industry professionals, government officials, and public stakeholders. This resource bridges knowledge gaps, supports informed decision-making, and fosters transparency and fairness in eminent domain practices.

## Phase I: Research, Concept, Platform Development

Estimated Budget: \$50,000

**Research:** Conduct initial research by compiling the current state statutes and regulatory code from every state. Summarize each state's law and identify seven common elements to form comparative tool between state laws.

**Concept:** Develop an up-to-date state-specific eminent domain law and policy platform for nationwide use by all stakeholders.

**Platform Development:** Create webpage for the *Eminent Domain Solutions Center* at Aii.org. This beta version webpage will begin with interactive maps allowing users to visualize state differences in approach to eminent domain. It will host multimedia resources and research as it is compiled.

## Phase II: Research, Comprehensive Data Analysis

Estimated Budget: \$250,000

**Research:** Compile all relevant laws, regulations, and caselaw at the federal and state levels along with certain localities and special districts. This research will focus on providing value to all stakeholders by providing easy access to all relevant legal information on eminent domain, objective element breakdown and analysis, and will be up-to-date with historic data through the latest developments.

**Comprehensive Data Analysis:** Integrate research findings and comprehensive data collected into user-friendly and readable formats, provide original insight, and present tools for users to derive their own insights (such as using a comparative tool) or serve their own future research efforts.

# Phase III: Refining Research, Maintenance and Update, Share Expert Analysis Estimated Budget: \$150,000, annually

**Refining Research:** Improve the research with in the platform by reviewing and tightening as needed and in response to stakeholder feedback.

Maintenance and Update: Ensure web development provides a seamless user experience. Add new information immediately when available. Keep the platform dynamic and responsive to evolving public policy and infrastructure developments. Share Expert Insight: Make experts available for public testimony, expert witness requests, hearings, conferences, and panels. Draw on expansive network of judges, lawyers, advocates, academics, and more to improve our research and platform.
